## Back pool updates:

- An engineer inspected the building that houses restrooms and storage area due to water intrusion. The structure was found to be sound and therefore will repair the roof and remove the lean to on the building. Restrooms walls will be replaced where needed from water damage and sinks replaced with vanities.
- Junk King \$750.00 to remove unwanted/damaged items.
- Poseidon Pools to repair step and coping next week.
- Spectrum to come 5/17 and install phone line at the back pool.

# Clubhouse pool updates:

- The leaking pool pump was repaired.
- The electrician was out to check the lights.
- Mae Fence scheduled 6/16/2023 to install fence and pool will need closed that day.

• Mike with Aqua pool sent a crew on Monday 5/15 to repair steps where Diamond Bright was cracking, and pool rail installed. Pool being filled with water as instructed per concrete company.

### **Reserve Study**

Board members met with Reserve Advisors and the study is in progress. The engineer walked the property to assess. This will take 4-6 weeks and he will present it to the board and then we will share the information with the residents.

### **Concrete Work**

Due to the budget(\$60,000) for this year concrete repairs will need to be scaled back to repair the serious safety concerns first. It was asked that some board members walk the property to mark with white paint trip hazards and holes.
